THE CORPORATION OF THE CITY OF OWEN SOUND

A BY-LAW TO PROHIBIT ENTRY ON CERTAIN PREMISES OCCUPIED BY THE MUNICIPALITY AND TO AUTHORIZE THE POSTING OF NOTICE PROHIBITING SUCH ENTRY AND TO REPEAL BY-LAW 1985-89 AND ANY AMENDMENTS THERETO

WHEREAS the Trespass to Property Act, R.S.O. 1990, Chapter T.21, provides authority for occupiers of premises to prohibit entry on such premises by posting notice to that effect and whereas provision is made for the removal or arrest of any person thought to be on the premises in contravention of a prohibition; and

WHEREAS the Council of The Corporation of the City of Owen Sound is desirous of prohibiting entry on certain premises occupied by the municipality and for the removal or arrest of persons thought to be in contravention of such prohibition.

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF OWEN SOUND HEREBY ENACTS AS FOLLOWS:

1. That unauthorized entry to the premises listed and described in Schedule A and Schedule B to this By-law be prohibited.
2. That premises listed and described in Schedule A to this By-law be posted in accordance with the provisions of the Trespass to Property Act, R.S.O. 1990, Chapter T.21, to give notice of the prohibition against entry on the premises.
3. That the By-law Enforcement Officer and the City of Owen Sound Police be and are hereby authorized to act on behalf of The Corporation of the City of Owen Sound in the removal or arrest of persons thought to be on premises where entry is prohibited.
4. By-law 1985-89 and By-law 1987-112 is hereby repealed.
5. This By-law shall come into full force and effect upon the final passing thereof.

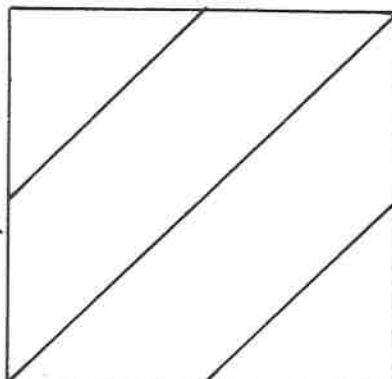
