THE CORPORATION OF THE CITY OF OWEN SOUND

A BY-LAW TO PROHIBIT MOTOR VEHICLES ON THE 7<sup>TH</sup> STREET EAST HILL ROAD ALLOWANCE BETWEEN THE BASE AND THE TOP OF THE HILL, EAST OF 5<sup>TH</sup> AVENUE EAST

WHEREAS Paragraph 42 of Section 208 of The Municipal Act, R.S.O. 1980, Chapter 302, authorizes Councils of Municipalities to pass By-laws for prohibiting carriages, wagons bicycles, sleighs and other vehicles and conveyances of every description, and whatever the motive power, or any particular kind or class of such vehicles or conveyances being upon or being used, drawn, hauled or propelled along or upon, sidewalk, pathway or footpath, used by or set apart for the use of pedestrians and forming part of any highway or bridge boulevard or other means of public communication, or being in or upon any highway, boulevard, park, park-lot, garden or other place set apart for ornament or embellishment or for public recreation; and

WHEREAS City Council by By-law No. 1989-6 has prohibited motorized snow vehicles on the 7th Street East hill road allowance from 220 feet from the northeast corner of 5<sup>th</sup> Avenue East and 7th Street East to a point 220 feet easterly therefrom; and

WHEREAS City Council deems it desirable to prohibit motor vehicles on the 7th Street East hill road allowance between the base and the top of the hill, east of 5th Avenue East.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF OWEN SOUND HEREBY ENACTS AS FOLLOWS:

1. In this By-law:
  - (a) motor Vehicle includes an automobile, motorcycle, motor assisted bicycle and any other vehicle propelled or driven otherwise than by muscular power.
2. No person shall operate a motor vehicle on the 7th Street East hill road allowance between the base and the top of the hill, east of 5th Avenue East.
3. Motor vehicles owned or operated or under the direction of the municipality or a public utility for the purpose of maintenance are hereby excluded from the provisions of this By-law.
4. Any person who contravenes any provisions of this By-law is guilty of an offence and is liable to a fine of not more than \$2,000.00 exclusive of costs under the Provincial Offences Act.
5. This By-law shall come into full force and effect upon the final passing thereof and when the appropriate signs have been erected.
